



No Win No Fee

The “no win no fee” system means claiming compensation is risk free
“No win no fee” means if your claim is unsuccessful you don’t pay a penny

“No win no fee” arrangements (of condition fee arrangements as they are formally titled) take the risk out of making an accident claim. Other than in exceptional circumstances (for example in clinical negligence cases) there are no up front fees, no unexpected costs and you will never be left out of pocket.

How does it work?

If your claim is unsuccessful you are not required to make any payment whatsoever in relation to legal costs and expense or otherwise. We simply do not get paid in such circumstances.

If your claim is successful we will do our utmost to recover the maximum compensation possible in the circumstances and on the basis of the evidence.

Background information

“No win no fee” claims were introduced to this country in 1995 to assist in helping people have access to justice even if they were unable to afford to pay for legal representation.

The government introduced very significant changes to the way in which this system works in April 2013. Prior to April the losing side generally were required to pay of the legal costs associated with the claim including success fee and insurance costs.

However, now solicitors are able to offer a “no win no fee” service as before but under the provisions of the law that has now been implemented claimants are expected to contribute to their legal costs from any compensation that they might receive.
