

#### **Our Services**

The department advises on all issues surrounding the breakdown of a marriage, civil partnership or relationships between unmarried parties. This includes issues concerning children and financial issues arising out of the breakdown of the relationship.

# **Our Approach**

In all cases our approach to divorce and separation is, save in exceptional cases, to aim to reach a negotiated settlement without recourse to litigation save where litigation is a necessary expedient. We shall refer you to mediation and counselling services where appropriate to your case.

### **Court Representation**

The Family Court system is geared to achieving settlement without a final contested hearing wherever possible. Issuing proceedings does not mean that there will necessarily be a contest. Where cases progress to a court hearing then we are committed to handling the matter sensitively and will remain alert to the possibilities of achieving a fair out of court settlement. We shall ensure that you are soundly and realistically advised throughout the proceedings.

Most cases are settled by agreement but in those cases where a contested hearing proves necessary we can offer an in-house advocacy service which will provide seamless representation by a professional who is closely acquainted with your case.

In particular complex cases or where you prefer to have an outside advocate we shall refer you to a specialist member of the Bar. Our trial advocacy experience will enable us to choose the right barrister for your case and to ensure that he or she is fully and sufficiently briefed to represent you. Where appropriate we may advise consultation with a specialist barrister at an early stage of the case.

#### What will it cost?

Barwells offers a private service and particulars of our fees are available on request. We offer fixed fees for non contested divorce as shown on our website. We will also agree fixed fees for every stage of the case. We shall always give you a reasonable estimate at the outset of the case and shall ensure that estimates are regularly updated. We shall not allow fees to take you by surprise. Our policy is to conduct cases in a way which will reduce costs, not increase them.

Legal costs are rarely awarded in Family Law cases but if costs are likely to be relevant we shall advise you.
